- ☆ Basic 3-6: Skaters ages 6 and up, these levels develop all of the fundamental skating skills on the ice.
- ☆ Pre-Free Skate, and Free-Skate 1-6, each free skate level is comprised of a variety of progressive skating skills, transitions, spins and jumps – all of which build on the previous skill, providing skaters a strong foundation of all elements.
- ☆ Adult 1-4: Adult beginning skaters

- ☆ Hockey 1-4, and Power Skating: Skating skills for hockey, including stops, stride, crossovers, tight turns, and small area games each week. Full equipment preferred, helmet with face mask required. Jersey included.
